

# ACCT 202: Managerial Accounting

**Course Theme – Is a strong manufacturing sector important to the future of the American economy?**

Welcome to Accounting 202, Managerial Accounting. My name is Mike Deschamps and I am the instructor for this course. This course has a variety of uses for you as a student, from meeting the transfer requirements for four year schools, to meeting the requirements for an Associates Degree or a Certificate here at MiraCosta College, to helping the budding entrepreneur manage the financial issues of their business. Whatever your goals are for this course, my goal at the end of the semester is for you to feel comfortable with financial information and have a working knowledge of how it is put together.

## Course Description

202 Managerial Accounting 4 Units

Prerequisites: None

Lecture 4 hours. (0502.00)

Theory and practice of accounting as applied to cost accumulation and product costing; managerial decision making; planning and control. This course addresses the cost-volume-profit analysis, relevant costs, budgeting, capital budgeting, and standard costing. This class is acceptable for credit in the CSU and UC system.

## Course Objectives & SLO's

**COURSE OBJECTIVES:** In this, the second transferable accounting course, the following objectives will apply:

1. Demonstrate knowledge of basic accounting concepts and apply these concepts to compute and analyze investments and financial statements.
2. Perform management accounting pertinent to manufacturing firms and analyze the differences in product cost systems.
3. Perform accounting pertinent to merchandising and service cost systems.
4. Explain cost-volume profit relationships and their application to forecasting.
5. Apply accounting in making operational and capital budget decisions, nonroutine decisions, and performance evaluations.
6. Demonstrate the ability to communicate through written, oral, and group projects.
7. Demonstrate your knowledge of key principles as it relates to the successful management of information, people and organizations.

**STUDENT LEARNING OUTCOMES:** SLOs are statements of expectation that clarify what students should know and be capable of at the end of instruction as a result of a faculty's interaction with them.

For this class, the following are the expected SLO's:

1. Construct and analyze accounting information for the purpose of making business decisions.
2. Prepare and evaluate information and reports used by management to plan, direct, motivate, and control manufacturing processes for various business costing models.
3. Develop a cost behavior model for the purpose of making business decisions.

The measurement of the SLO's for this class will be done via an SLO project in the on-line homework platform, Connect Plus, which is discussed later in the syllabus. You have the right to expect to be able to master the class SLO's provided that you have made a diligent and committed effort to the requirements for this class.

I was a peer counselor in the EOPS program as well as a tutor for accounting and business. The other reason that I love teaching at this level is the opportunity to help mentor students in believing in themselves and their abilities and in finding a career path that will work for them.

## Course Materials

### TEXT AND RELATED MATERIALS:

1. **Managerial Accounting MiraCosta College Custom Edition**, (Loose-Leaf) – *Wild and Shaw*, McGraw-Hill Publisher, 5<sup>th</sup> edition, Chap 1-13; ISBN **9781259733635** (**Note: this is the special MCC bookstore package ISBN**). **Required.**

2. Connect PLUS access code for utilizing the on-line homework module (Included in the MCC bookstore package). **Required**

**Text Options:** In an effort to reduce the price of the textbook for this course, the accounting department has negotiated a special deal with the publisher that includes a custom edition for MiraCosta College, derived from *Wild, Managerial Accounting, 5<sup>th</sup> edition*. This custom edition is in a loose-leaf format and includes the access code needed for **Connect Plus**, the on-line home work module as well as the e-book. *Having this code and utilizing the on-line home work module is a requirement of this class.* **The price of this book in the bookstore is approximately \$120**, which represents over a hundred dollar savings from what students had to pay several years ago for the textbook for this course. **Just to buy the Connect Plus access code itself will cost about \$130**, either at the bookstore or on-line at the publisher's website, not including the price of the textbook, **so purchasing the custom edition at the bookstore is probably your most cost efficient option.**

Do note that with the loose-leaf edition there is no bookstore buyback at the end of the semester. Because of the low price of the custom edition, you are getting your savings "upfront", at the purchase point of the text, which our research showed most students preferred. Also note that once the shrink wrap is removed, the textbook is no longer returnable to the bookstore. If you are unsure if this is the course for you, before opening the text during the first two weeks of class, you have several options:

1. If you cannot buy the book during the first two weeks of class, there will be several copies at the reserve desk in the Library, both on the Oceanside and San Elijo campuses. You are allowed to check out the text and use it in the library for several hours at a time.
2. **Students can access the FREE 14 DAY TRIAL in Connect, including e-book, as follows:**
  - Click on instructor's Connect course URL
  - Click "Register Now" button
  - Click "Start Free Trial" button

**The Free Trial entitles students up to 14 days of Connect Plus, which will start on 8/23. Students will be reminded how many days they have left to purchase. If you need help with this, please contact CONNECT CARE at 800-331-5094.**

Please remember a couple of important points as you ponder your textbook options: **Having access to the current edition of this text is a requirement of this course, as well as having a Connect Plus access code for the on-line home work manager. Failure to do so will result in either/or your being dropped from the course or issued a failing grade.** The accounting department has expended a great deal of time and energy to provide our students with the most cost efficient options as it regards the materials for this class and we urge you to consider your options carefully as regards meeting the requirements for this course.

## Course Content

**MODE OF INSTRUCTION:** This course will be conducted on a lecture, discussion, group tasks and problem-solving basis. I will include audiovisual and computer demonstrations that are relevant to the material being covered. Your active participation in this class is a vital element of the learning process. In order to encourage class discussion, group assignments and oral presentations will be part of the curriculum.

**CHAPTER LECTURES:** Please read the assigned chapter in the book and the chapter lecture notes (*which you will find posted on the class website*) prior to the start of the discussion of each chapter. Also, feel free to bring in articles or news reports that are relevant to the topics being covered in a chapter. This will not only enhance the class participation portion of your grade but will help to make the topic more interesting for us all.

**HOMEWORK:** In accounting, new concepts build upon those that have come before. It is essential that you *keep current* in this course. A good rule of thumb is to expect at least two hours of work outside of class for every hour spent in class. Failure to complete homework assignments may result in your grade being lowered by one or more letter grades. Homework assignments are designed to help you practice new skill sets and to learn the key concepts that accompany them.

**All homework will be done on-line in Connect Plus**, which will be available through a link on the class Blackboard site. In the on-line environment, you may submit your homework assignment a specified amount of times before the due date and your best score will be retained. If at any point in the semester you experience technical difficulties with Connect Plus, please call their technical support line at 1-800-331-5094, or you can contact them via the web at [www.mhhe.com/support](http://www.mhhe.com/support)

**It is a requirement of this course that you have a Connect access code and that you complete your homework assignments in Connect. This system is designed to help you achieve maximum success in this class and I urge you to utilize it effectively.**

**Very, Very, Important!** – ***If you miss more than three Connect HW assignments over the course of the semester, you may be dropped from the class for lack of academic progress. Using the on-line HW management system, Connect, is a required element of the class.***

It is your responsibility to complete the homework assignments on time and late homework will sustain a significant penalty. In order to ensure your maximum grade and learning benefit from the homework assignments, I would urge not to wait until the last minute to submit your assignments. **This is why I think that the completion of HW is so important: There is a direct correlation between success on the exams and diligent effort on the homework. By seriously attempting to solve the HW problems, you will learn the material and, as such, be more successful in the class!**

**EXAMS:** There will be 2 midterms and a final exam in this class. Each exam will cover four chapters and the final exam will have a 20 to 30% cumulative element to it. The exams will be a mixture of multiple choice, true/false, and short answer questions and problems and will be based upon the class lectures, homework, quizzes, and group work. Generally speaking, **no make up exams** will be given so it is imperative that you sit for the exams as scheduled. I will handle tests that you have missed for documented medical or other legitimate reasons on a case-by-case basis. The burden of promptly scheduling a meeting to discuss missed tests or other assignments is your responsibility as a student in this class. **Only simple calculators**, with no advanced memory functions, will be allowed for exams or quizzes and no cell phone calculators will be allowed as well. **You must bring a scantron (#882-E) to each exam.**

Prior to each exam, I will post **an exam review sheet** on the class blackboard site and the class meeting before the exam will be reserved for going over homework and discussing those items on the review sheet that you have questions about.

My exams are not totally true/false or multiple choice. I always have one or two lengthy problems on an exam that have to be hand graded by me so as to allow for partial credit on the problems. **Therefore, expect it to be a week to ten days before exams are returned. Also, you are not allowed to keep your exams in this class but you will have access to them during my office hours.**

**QUIZZES:** There will be a series of quizzes throughout the semester. The purpose of these quizzes will be to keep you on track with the material and allow both you and I to assess where you are with the subject matter. **I will drop your two lowest quiz scores. You must bring a scantron (#882-E) to each quiz.**

**CLASS SLO PROJECT(S):** There will be a class SLO project(s) that will be assigned during the semester. The purpose of this project(s) is to reinforce the skills and techniques that we have covered in class and to give you a better sense of how these individual concepts fit in the overall management accounting reporting process. **It is a requirement of the class that all students participate and complete the class SLO project(s).**

**WRITING:** Your writing matters. The quality of your writing will affect your grades on examinations and other assignments. Good writing conveys your ideas more effectively than poor writing. The better you write, the more likely your writing will demonstrate your knowledge of the course material. Surveys of managers

consistently show that they consider the lack of adequate communications skills to be the greatest deficiency of the graduates they hire. To be more effective in your career, work to improve your writing in this course.

**EXTRA CREDIT:** *There will be an ongoing extra credit assignment throughout the semester that will be available in Connect, the on-line Homework Management System.* The process to access this will be explained in class and total extra credit will not exceed more than 3% of your grade.

**CLASS SPEAKERS:** When possible, I will schedule some class speakers whose knowledge and experience can add substance to the content being covered in class.

**DUE DATES:** The due dates for all assignments and the scheduled dates for lecture topics, reviews, and exams are clearly listed on the class schedule that you will receive. *Therefore, I expect you to come to class prepared and late assignments will not be accepted.*

### **Something to think about!**

**Employment change.** Employment of bookkeeping, accounting, and auditing clerks is projected **to grow by 10 percent during the 2015–2025 decade**, which is about as fast as the average for all occupations. This occupation is one of the largest growth occupations in the economy, with about 212,400 new jobs expected over the projections decade.

**Job prospects.** While many job openings are expected to result from job growth, even more openings will stem from the need to replace existing workers who leave. **Each year, numerous jobs will become available, as clerks transfer to other occupations or leave the labor force.**

By taking just this one course, you will be eligible for the **California Registered Tax Preparer certification**, which will allow you to do taxes for a fee. This can lead to both part-time employment and internship opportunities that will look excellent on your resume as well as helping you to develop some outstanding technical skills.
